*We believe that the Lord Jesus Christ died for our sins according to the Scriptures as a representative and substitutionary sacrifice; and that all who believe in Him are justified on the ground of His shed blood.*

*We believe in the resurrection of the crucified body of our Lord, in His ascension into heaven, and in His present life there for us as high priest and advocate.*

*We believe in "that blessed hope," the personal, pre-millennial and imminent return of our Lord and Savior, Jesus Christ.*

*We believe that all who receive by faith the Lord Jesus Christ are born again of the Holy Spirit and thereby become children of God; that they are thereafter indwelt by the Holy Spirit who makes possible a life of personal holiness and a walk of obedience to the will of God; that all who are truly born again are "kept by the power of God" and, therefore, are incapable of losing their salvation.*

*We believe in the bodily resurrection of the just and the unjust, the everlasting blessedness of the saved, and the everlasting, conscious punishment of the lost.*

*We believe that the local church is a body of believers organized for worship, work, and fellowship; that the two ordinances of the church are baptism by immersion and the Lord's Supper; that the local church is an independent and self-governing body responsible alone to Christ who is its Savior and Lord.*
